- ✓ Please check bulletin board (registration building) for open pit pads. \$20 per pad will be charged. Please call to reserve a pad.
- ✓ Upon arriving, all drivers will draw for heat positions.
- ✓ Qualification for feature position through heats.
- ✓ Total of 30 cars to start event.
- ✓ Each team may purchase five tires for the event.
- ✓ Hoosier 1070 & 1070 SH only.
- ✓ Cautions: All green unless time constraints. You will not lose a lap for pitting under caution. Position is determined at time of caution. No passing under caution. Single file through caution zone.
- ✓ Laps 1 – 90: lap cars holding position as running. Laps 91-100: lead cars in front, lap cars to the rear.
- ✓ All restarts are double file until lap 90.
- ✓ Race must finish green/white/checkered.
- ✓ Lucky Dog – first lapped car if does not cause caution
- ✓ Two way radios permitted. The driver must monitor 154.570 for race control. MUST register frequency with Pit Steward.
- ✓ Weight: SST Rules. 2600 before the feature 56% left side weight.
- ✓ \$35 pit passes for anyone with a track license (NASCAR, Holland, SST, Wyoming). Must be presented at sign in. \$38 without a license.
- ✓ All cars must be pre-inspected before practice.
- ✓ Speedway reserves the right for two provisional positions, 29 & 30, for the top 10 in Holland points.

**Suggested Directions to Track:**

*From the West:*

Take I-90 East to Exit 54 Route 400 (West Seneca / East Aurora exit). Continue to the end and merge on to Route 16 / Olean Road. Continue on Route 16 to third traffic light, make a right on Holland-Glenwood Road and Speedway is one mile on the right.

*From the East:*

Take I-90 West via exit 1 toward Buffalo. Continue on I-90 West to Exit 54 Route 400 (East Aurora / West Seneca exit). Continue to the end and merge on to Route 16 / Olean Road. Continue on Route 16 to third traffic light, make a right on Holland-Glenwood Road and Speedway is one mile on the right.

*From the South:*

Take I-86 East / NY 17 E / Southern Tier Expressway to exit 27 towards Hinsdale Route 446 to Route 16 North. Follow Route 16 North to Holland and make a left at Holland Glenwood Road. The Speedway is one mile on the right.

**TERMS OF AGREEMENT**

**CONTRACT:** I am an independent contractor assuming all responsibility for money received as a result of my activities including but not limited to income tax, FICA, Workmen's Compensation, and withholding taxes. I am not an employee or agent of the Speedway.

**BENEFITS:** I agree that myself, heirs and assigns will be entitled only to the benefits of the Competitor Accident Policy procured by the Speedway for accidental injuries or death which are the result of external, violent, and visible means sustained in Speedway activities. The foregoing shall constitute the limit of liability of the Speedway for such injuries occurring to me in any Speedway events; I unconditionally release and indemnify the Speedway regardless of the cause and nature of the injury or death.

**COMPLIANCE:** The undersigned agrees to abide by all rules and regulations of the Speedway, now or hereinafter promulgated. In consideration of the acceptance by the Speedway of this agreement, the undersigned recognizes his obligation to the public and the Speedway, which posts the prize money and conducts the event, and agrees to compete in all events when qualified if humanly possible.

**BREACH & DAMAGE:** In the event the undersigned breaches this agreement, he shall be liable for actual and liquidated damages sustained by the Speedway.

**OWNERSHIP:** As owner of a registered car, I certify I have marketable title to the competition vehicle, free and clear from liens and will deliver title to said vehicle or any part thereof if claimed pursuant to the rules.

**ADVERTISING RELEASES:** The undersigned consents to the use of his name, pictures of himself and his car for publicity, advertising and endorsements both before and after the events, and relinquishes any rights to photos taken in connection with events and consents to the publication or sale of such photos as the Speedway desires.

**ARBITRATION:** Any controversy or claim arising out of or relating to this agreement, including any alleged breach, shall be settled in accordance with the rules of the Speedway. The undersigned agrees to accept the decision as final without appeal.
